### Announces Launch of Eiffel eCapital

### Eiffel Investment Group (Paris) launches Eiffel eCapital a new asset manager focused on the online lending market

Eiffel eCapital<sup>(\*)</sup> manages a range of funds and separate accounts invested through leading on-line lending platforms in the US, the UK and continental Europe. Its funds allow institutional investors, and family offices to access this attractive, fast growing and increasingly complex market (in the US and Europe alone more than 300 platforms exist). Eiffel eCapital is currently deployed across a dozen platforms with a current focus on the US and the UK. Underlying assets range from consumer loans to small business loans, invoice discounting and trade finance.

"The online lending industry's explosive growth represents a fundamental shift," said Etienne Boillot, CEO and founder of Eiffel eCapital. "Today, consumers and small businesses can borrow directly from savers and investors, rather than from banks who no longer have the desire or ability to lend to them."

## Eiffel eCapital's investment strategies target un-levered annual returns of 5% to over 10% (net) with very low volatility and almost no correlation to other asset classes

On-line platforms through which Eiffel eCapital invests originate loans yielding from 5% to over 15%. Loans average 2 to 5 years in length, feature monthly amortization of principal and monthly interest payments and therefore have short durations. EeC's strategies deliver attractive and steady cash flows (typically 2% to 3% of principal per month). Because the platforms allow diversification across thousands of underlying loans, historical performance has displayed extremely low volatility and no correlation to equity or fixed income markets.

### The investment team is one of the most experienced in this asset class

Led by Etienne Boillot and Jean Benoit Gambet, the Eiffel eCapital team has been involved in the on-line lending industry since 2009 and is among the 5 largest institutional investors on several leading platforms in the US and UK. Mr. Boillot is recognized by the on-line lending industry as one of its key players. He has over 30 years of finance and investment experience in the US and Europe and is also involved as an equity investor in over a dozen platforms worldwide. Mr. Gambet is a former trader at Dexia. The team tracks over 100 platforms globally and has diligenced over 50 of them.
